Ledwig Dance Academy Company 2022-2023

We are so glad you're interested in being a part of Ledwig Dance Academy's Company (LDAC). Our competitive dance team is a great way to further one's dance abilities and learn to work with others on a team.

Your child's dedication is important to the Company. When joining a team, your commitment is for the whole year (August-May). You are committed to attending all practices, working on your dances away from the studio, and attending all performances and competitions. We work as a team and need all members to cooperate for the team to succeed.

Parents are also very involved when their child is an LDAC member. Dancers need their instructors at dance class to push them and continually help them set goals for themselves. They can only achieve these goals at a quicker rate with practice at home. This is where parents come in. We want you to encourage your dancer to practice at home. It also helps when you sit down with them for a few minutes each day to work on their dances and skills.

Your child will experience excitement when they master that new skill they have been working on for a while or are put in front of the formations in the dance. They will also experience disappointment – when they set a goal that they didn't meet by the end of the year; or when they want to move up in company every year but aren't quite ready yet. It's a great life skill to learn that the answer isn't always going to be yes.

Please remember that we are a dance family. We are to encourage one another and be a part of a team. We, as a team, do not talk down to another dancer, parent, or director. If there is an issue it is to be addressed with Ms. Stephanie immediately.

Because we believe that dancers improve when learning from various teachers/choreographers, we attend conventions and/or travel to other states as a learning opportunity. Every other year we take a trip. The years in between we attend conventions. Trips are not required but highly recommended. The students must be 11 years or older to attend and must be in a ballet and jazz class. For conventions we take our intermediate (depending on age), junior, and senior teams. More information is listed below.

Please read this packet carefully and through its entirety. There is a fees list and important dates sheet included. We schedule meetings, practices, and payments which will be available on the calendar. We will also send out a calendar once dates are finalized.

2022-2023 Teams/Requirements

We have 4 teams a part of our LDAC:

- Tots (Beginner)
- Intermediates (Intermediate)
- Juniors (Intermediate-Advanced)
- Seniors (Advanced)

NOTE - We may add or remove any team if circumstances change.

Students are placed in groups by audition only. *Auditions are held on May 6th at the studio.* There is an audition fee of \$15/dancer. This fee is due at the time of auditions with your audition form. We will not be accepting payment or forms earlier than May 6th. Any students who miss the audition can schedule a private audition on another day.

Classes

- All company members must register for their designated weekly company class. Listed below are the classes required for company. *These may alter/change until the fall 2022 schedule is released.* We require regular dance classes so they get their technique in.

Tots - Ballet/Tap/Jazz Class, Company Class

Intermediates - Ballet/Tap/Jazz, Strength/Improv, Company Class

Juniors & Seniors – Ballet (twice weekly), Jazz, Lyrical/Contemporary, Strength, Company
We offer other classes that are not required but HIGHLY recommended – Acro, Tap, Hip Hop.

Summer Requirements

- **Tot Co** – 1 regular summer class, August Choreography Classes (Aug 1-11, M&W 4:15-5pm), Company Skills Class (June 27-July 7, M&W 4:45-5:30pm)
- **Intermediate Co** - 2 regular summer classes, August Choreography Classes (Aug 1-11, T&TH 4:30-5:30pm), Company Skills Class (June 27-July 7, T&TH 4:30-5:30pm)
- **Junior Co** - 2 regular summer classes, August Choreography Classes (Aug 1-11, M&W 5-6:15pm), Company Skills Class (June 27-July 7, T&TH 5:30-6:30pm)
- **Senior Co** - 2 regular summer classes, August Choreography Classes (Aug 1-11, T&TH 5:30-6:45pm), Company Skills Class (June 27-July 7, T&TH 4:30-5:30pm)

Attendance

- All company students are allowed ONLY 4 absences combined from regular required classes and company classes. This is in affect from September-December.
- From January through the end of competition season (March or April), only 2 absences are allowed from regular classes and company classes.
- To be counted present the student must be in class for 75% of the class time.
- Make-up classes or private lessons are to be scheduled for anyone who is absent more than what is allowed.
- In the event that more than the allowed number of classes are missed for any reason, the dancer may be pulled from a dance for one competition.

Accounts

- Accounts are to be up to date always. This includes company fees and regular dance class fees. Your account should never be more than a couple of weeks past due. Late fees of \$10 will be applied to all fees where payment is more than two weeks late. No exceptions will be made.
- Students will be dismissed from company if account is more than one month past due.

Fundraising

- We offer several fundraisers throughout the year. Most are optional.
- We have a raffle fundraiser that is mandatory. Dancers will be required to sell X amount of tickets. Details will be sent out at a later date.

Competitions

- We attend 3 competitions a year. Competitions are mandatory unless otherwise stated.
- Competitions usually fall between the months of February and April.
- Specialty numbers are not required to attend more than one competition each year but are welcome to.

Special Performances

- The LDAC members perform at least once per year in the community. Performances are mandatory and you are notified as soon as possible.

Specialty Numbers

- Company dancers have the option to do a specialty number (solo, duet, trio).
- Dancers must be approved for a specialty number before picking music and a choreographer.
- If your dancer wants to do a specialty number, they must understand that a lot of practice and work at home is important to succeed. Both the dancer and the parent(s) need to understand this before committing.
- Choreographers must be staff at Ledwig Dance Academy.
- Music must be approved by LDA before starting choreography.
- Specialty numbers must be started by November 1st to allow time for practice.
- The choreography fee is \$120 and your specialty number will not be started until this fee is paid in full. Lessons to learn the choreography are the cost of a 1-hour private lesson, \$40.
- Dancers doing a specialty number are REQUIRED to take a minimum of two one-hour private lessons before competition.
- This rule is subject to change! In order for your dancer to compete their number in recital they must achieve one of the following:
 - 8 hours of private lessons (with an LDA staff member) and a score of 80% or higher at competition.
 - 2 hours of private lessons (with an LDA staff member) and a score of 92% or higher at competition.
- We do not make exceptions to participating in recital.

Communication

- We communicate via email and text messages. Read your emails! They have all the information you need to stay up to date on payments and important dates. We also have a Facebook group specifically for company.
- All members are required to sign up for our convenient text updates. Text @ldacompa to 81010. The service is free and helpful to us both!

Dress Code

- For company practices, all members must be in black fitted dancewear.
- Tights are not required for company classes.
- Jazz shoes are required for ALL groups.
- Intermediate and Tot groups will need black tap shoes – Lace up for Intermediate & Velcro for Tot.
- Juniors and Seniors will need lyrical toe paws/half soles.
- Hair must be up and away from the face.

Behavior

- Company members are to be on their best behavior at all times.
- They are to display respect for their fellow dancers and directors while in class.
- If any teacher feels a student is disrespecting the teacher, students, or environment, the student will be asked to leave.

Conventions/Trips

Every other year, junior and senior dancers will be required to attend convention. (Depending on the age at convention, intermediate dancers may be required to attend as well). Convention can be pretty expensive which is why we encourage fundraising. The cost ranges from \$200-\$300 per dancer. The convention usually lasts for two days and dancers train with some of the BEST dance teachers, instructors, and choreographers in the industry.

Company Fees

Company can get very costly which is why we have all our fees listed below. Please note that regular dance fees are not included in these fees (Example: tuition, recital costumes, etc.). Budget accordingly as paying late WILL NOT be accepted.

Tuition/Month

- Monthly company tuition cost is \$35 for tot and intermediate members and \$45 for junior and senior members. This will be added to your monthly tuition for regular classes.

Fees

- All company dancers will need costumes for their dances. Prices are listed:
 - Tots, Intermediates (2 costumes) - \$125 total plus tax
 - Juniors, Seniors (3 Costumes) - \$185 total plus tax
- Drop Fee –If you must drop company for any reason, there is a \$25 drop fee due within 7 days of the drop day.
- Privates (If Needed) - \$40/Hour
- Competition Fees – Competition fees vary depending on competition. Here is a rough estimate:
 - \$70-\$95/Group Dance
 - \$145-\$175/Solo
- Choreography – It takes time and talent to choreograph a solo/duet/trio. We charge a \$120 choreography fee due before the first practice. Private lesson fees will apply to teach the dance to your dancer.
- Jacket – All company members are required to have a company jacket which costs between \$80-\$95
- Performance Tee – All company members are required to have a performance tee which will cost \$25-\$30.
- Shorts – Company members will need black booty shorts - \$12-\$18
- Nude tights – We sell nude tights which they will need for competition and recital - \$12
- Leotard – A plain black leotard is needed to wear under dance performance clothes at local performances.
- Earrings – Dancers will need performance earrings. We sell them for \$14 plus tax.

Required Skills

The skills listed below are requirements for anyone hoping to join company. We take into consideration that some skills can be learned in a few classes. However, most skills will need to be learned before auditions.

All dancers, ages 8 and under, will audition for the tot and/or intermediate competitive groups. We look for dancers who are focused, love to dance, and want to learn more.

Any dancer age 7-8 can be considered for junior company depending on skill level. If they meet the required skill level needed for junior company, they will be given the option to dance with the junior co. for the new season.

Junior Company

- Double Pirouette (prep from 4th & parallel)
- Leap (right & left)
- Russian
- Chaine Turns & Pique Turns
- Control of arms & upper body

Senior Company

- Double & Triple Pirouette (prep from 4th & parallel)
- Leap (right & left)
- Russian (right & left)
- Chaine Turns & Pique Turns
- Calypso
- Circular Disk
- A la second turns (3 consecutive & single or double pirouette finish)
- Control of arms & upper body

While the skills listed are not the only ones needed to be considered for these groups, they are the ones that are expected to be mastered before being accepted.
